The e-zine includes articles, interviews, news and views on themes surrounding global issues, critical pedagogy, critical literacy and activism within the field of ELT. We warmly welcome contributions and suggestions for future publications from both members and non-members, in line with the aims and mission of our SIG.

What are 'global issues'?

There are many pressing challenges, trends, changes and concerns facing humanity. Some of us are privileged enough to live in places where we don't immediately experience their adverse effects. - Globalisation and consumerism
- The role of English and ELT in the world
- Critical literacy and critical pedagogies

Contribution Length and Format

Contributions include articles (academic/opinion pieces, project reports, practical teaching ideas, conference overviews etc.), lesson plans and reviews.

Submissions should be:

- Between 500-1500 words in length (excluding references). If you would like to exceed this word count, please contact us in advance of submission.
- Written in clear, neutral English (not overly academic in style)
- Typed using Calibri or Aerial fonts (size 12) with any headings in **bold**
- Not overly referenced (a suggested maximum of five references per article)

Images

Any images to accompany the text must be high-quality and sent as attachments. Children's faces must not be visible in any image, unless the author can provide evidence of written permission from their parent or guardian. Obtaining permission for the use of all images submitted with the article is the responsibility of the author.

References

Please ensure that all sources cited in your text appear both in the text, e.g. (Smith, 1998) and in a reference list at the end of the article. Your reference list should adopt a universally recognised style of referencing, e.g. Harvard, APA etc., and should include only sources that have been previously cited in your text.
